The NOC is issued subject to the execution of agreement with Government in the prescribed format and the schools shall submit the UID details as soon as the process is completed.

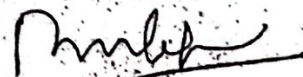

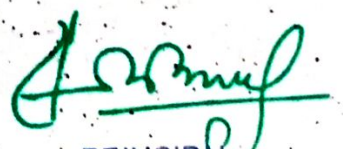
